## DETAILS

**Terms of Use Agreement:** The Term 'We' or 'us' or 'we' or 'our' refers to 'EzyTax Thailand' and 'You' or 'you' or 'your' refers to the Applicant and 'IRS' refers to the 'INTERNAL REVENUE SERVICE'

### Rights, Terms and Conditions of the 'Applicant'

- You agree to authorize us the power of attorney for doing tax, banking and financial matters.
- You agree to submit the significantly relevant documents as the requirement of either the US authorities or IRS within the announced due date.
- You verify that your submitted documents and information is true and correct.
- You reserve the right to cancel of application using if your tax return has not been filed under our service fee conditions.
- You acknowledge that we are just the representative to receive and inspect confidential tax information and to perform any and all acts that you perform with respect to the tax matters in accordance with Form 2848 details but the right to either consider or approve is solely reserved by the IRS or US authorities.
- You have not to pay any fee if you do not receive the refund check, except the deposit or the additional service fee(s).
- You acknowledge that we perform just only tax matter under our conditions.
- Your general application is apply for the Federal Tax return only. Other additional services do not include. (APP2010/01 and/or APP2010/02)

### Rights, Terms and Conditions of 'EzyTax Thailand'

- We agree to process the tax documents and forward them to the IRS respectively in a timely manner and in compliance with the United States of America laws.
- We agree to use the authorities under the Power of Attorney as the stated in the Form 2848 only.
- We agree to report the service costs to you after the completion of payment.
- We agree to proceed for only person who signed our entire requirements.
- We reserve the right to deny or cancel to provide the service for any cases without prior notice.
- We have no responsibility for any cancelled, refused or denied by the IRS
- We have no responsibility for any delayed, lost, damaged, stolen, returned or other unexpected events in process of delivery both international and domestic.
- We agree to deliver or give the check to whom may make completely payment.
- The deposit of 'Early Bird' package is non-refundable in case of your cancellation in any cases.
- We reserve the right to seize the check or refund if you lack of show up or lost contact longer than 12 weeks after we report you by email and phone.
- We have responsibility to deliver your check by registered mail.
- The refund of Federal Tax fiscal year 2009 will be automatically deposited into your personal account.

### Costs that Not Included

- 200 THB for each additional W2 form
- 100 THB fee for processing refund by LAST PAYCHECK
- 50 THB for nationwide delivery by 'Express Mail Service' (EMS)
- International delivery fees upon the destination; 600 THB for ASEAN, 1,000 THB for Asia Pacific and Oceania, 1,200 THB for Middle East, 1,500 THB for Europe and North America and 2,000 THB for South America and Africa region.
- 120 USD for ITIN service
- 50 USD for asking 'ADJUSTED GROSS INCOME'
- 400 THB for direct deposit, plus 2.5% of total value as shown in the check (Fluctuation Currency Risk surcharge) for direct deposit service -Fee will be deducted from check.
